A Brief Explanation

The 111th Congress has had a disappointing record on international trade and tax policy. It missed a number of opportunities to expand U.S. exports and jobs, which could have been extraordinarily beneficial given the rise of unemployment in the United States following the financial crisis. Agreements with Colombia, Panama, and Korea are still pending and could help end the recession that the U.S. is currently experiencing.

Another hindrance has been the expiration of trade negotiating authority granted to the President. The last law expired in 2007, and has yet to be renewed. This will present a problem in the upcoming Trans-Pacific Partnership and Doha Round negotiations, as the current administration has yet to receive authority to conclude these agreements.

Because of the lack of progress made in the past two years, the NFTC has chosen to give all members of Congress an “incomplete” on the scorecard this year. Scores are still presented on various pieces of legislation, but due to the shortage of bills to choose from, it is impossible to grade members accurately.
